Terms and Conditions

I/We hereby make application to become a member of the Employers and Manufacturers Association (Northern) Inc and agree to be bound by the rules of the association and the following specific terms and conditions below.

1. The subscription payments by members are based on a return of each member's total current annual salaries and wages (excluding Director's Fees, Bonuses and Commission and Redundancy payments) or for a new business the projected annual payroll.
2. The salaries and wages of employees of subsidiaries and branches or divisions of any firm are to be included in the return, except where the subsidiary branch or division is a subscribing member. A member shall remain a member until written notice of resignation signed by the member or authorised agent is delivered to the Association and payment for any outstanding subscriptions due is made.
3. Membership is for a 12 or 24 month term, irrespective of payment type. Members resigning after their membership anniversary date, maybe billed for that years membership or part thereof - at the Association's sole discretion.
4. The information provided by the Association is for the confidential use by the member for the business covered by the subscription as listed on the front and supplementary list of branches/ subsidiaries. The member undertakes not to use or disclose the information for the benefit of other organisations.
